Individual alleged by Gary Lee Vincent to have exploited him sexually. See Exhibit VID-III for the video taped allegations.

Minister at Grace Apostolic Church located at [REDACTED] Street, Omaha, Nebraska. Alleged to have counselled individuals abused by Larry King. Judy Carroll

Former employee of the Franklin Credit Union.

Dennis Carlson

Former Vice Chairman of the Foster Care Review Board. Was instrumental in bringing to light allegations of child abuse in 1988. Business telephone [REDACTED] See Exhibit X-7.

Judge Theodore Carlson

Former lover of Larry King's. Currently may be residing in California. Has remitted information to Mike Casey, however, he has not cooperated with this investigator, nor had Mr. Casey
