**PURDUE’S UNOPPOSED MOTION FOR EXTENSION OF TIME TO

Purdue moves the Court for an order extending the time to respond to the Motion to Intervene by ten (10) days, to May 16, 2019. Comanche County does not oppose the requested extension. In support of this request, Purdue shows the Court as follows:


1. Comanche County filed the Motion to Intervene on April 15, 2019. According to the Certificate of Mailing, Comanche County served the Motion to Intervene by mailing it to Purdue and the parties to the above-captioned action on April 16, 2019.
2. Without this requested extension, Purdue’s response to the Motion to Intervene would be due on May 6, 2019.
3. Purdue has not been granted a previous extension of time to respond to the Motion, and there are no scheduled deadlines that would be adversely affected by granting the requested extension.

4. On May 1, 2019, counsel for Comanche County stated that he has no objection to the requested extension.

5. Granting this extension would make Purdue's response to the Motion to Intervene due on May 16, 2019.
