# DEFENDANTS' MOTION TO EXCLUDE TESTIMONY OF JOHN L. DUNCAN, PH.D. AND BRIEF IN SUPPORT

STATE OF OKLAHOMA S.S. FILED

In the office of the Court Clerk MARILYN WILLIAMS Defendants<sup>1</sup> move this Court for an order pursuant to 12 O.S. §§ 2702-2705 excluding testimony of the State's purported expert witness John L. Duncan about (1) the purported effects of Defendants' opioid marketing on opioid prescribing in Oklahoma and Oklahoma law enforement efforts and (2) any purported causes of the opioid epidemic in Oklahoma. Duncan, a former martial arts instructor and retired police officer, holds a doctorate in philosophy. He has no training in marketing or statistics. He therefore lacks the qualifications to offer opinions on causation or the effects of marketing. Moreover, none of Duncan's marketing or causation opinions are based on reliable information or methods. Duncan instead relies entirely on anecdotal evidence from his personal experiences with Purdue—a manufacturer no longer party to this litigation—then purports to extrapolate to Defendants based on a handful of documents he reviewed for the first time the day before his deposition. Such insufficiently grounded "expert" testimony is inadmissible, and the Court should exclude it.

## **BRIEF IN SUPPORT**

In support of this Motion, Defendants show the following:

# I. <u>INTRODUCTION</u>

Oklahoma law requires the Court to exclude an expert's opinion unless he has both the qualifications necessary to offer and a reliable basis for *that particular opinion*. Duncan has neither. He opines that Defendants' marketing "successfully influenced the understanding of prescribers and State law enforcement officials" about opioids. Ex. A, Dec. 21. 2018 State's Expert Witness Disclosure of John Duncan, PhD ("Duncan Disc.") at 1. Duncan also opines on the

"cause ... of the opioid crisis in Oklahoma." *Id.* But Duncan has no expertise in marketing, statistics, or establishing causality. *Id.* at 5; Ex. B, Mar. 27, 2017 Deposition of John Duncan ("Duncan Dep.") 44:11-17. And Duncan relies on no data or calculations that could establish the effects of marketing or causality; instead, he relies on personal anecdotes to make sweeping generalizations about opioid marketing and its effects. *See, e.g., id.* 154:1-12, 155:3-24. Even if personal anecdotes were a reliable basis or method for opining on the effects of marketing or causation, Duncan admits that his personal anecdotes relate only to Purdue—not Janssen or Teva. *Id.* 172:1-174:18, 216:24-218:24. Duncan's opinions on both subjects are thus inadmissible and must be excluded under Oklahoma law.

# II. <u>LEGAL STANDARD</u><sup>2</sup>

Expert testimony is admissible only if it satisfies two requirements: the expert is qualified and the expert's opinion is the product of a reliable basis and method. *See, e.g., Christian,* 2003 OK 10, ¶8-9, 14, 65 P.3d at 598-600 (adopting *Kumho Tire Co. v. Carmichael,* 526 U.S. 137 (1999), and *Daubert v. Merrell Dow Pharm., Inc.,* 509 U.S. 579 (1993), as providing "appropriate standards for Oklahoma trial courts in deciding the admissibility of expert testimony in civil matters"). First, the expert must be qualified by "knowledge, skill, experience, training or education" to offer the particular opinion in question. 12 O.S. § 2702; *see Alexander v. Smith & Nephew, P.L.C.,* 98 F. Supp. 2d 1287, 1292-93 (N.D. Okla. 2000). Second, the testimony must be reliable, meaning (a) the opinion is "based upon sufficient facts or data," (b) it is "the product of reliable principles and methods," and (c) "[t]he witness has applied the principles and methods

reliably to the facts of the case." 12 O.S. § 2702; accord Nelson, 2016 OK 69, ¶¶10-14, 376 P.3d at 217. The party offering the expert testimony—here, the State—has the burden of showing by a preponderance of the evidence that the testimony is admissible. Christian, 2003 OK 10, ¶¶23-24, 65 P.3d at 603-04.

An opinion based only on speculative assumption and unsupported by reliable data must be excluded. See, e.g., Guidroz-Brault v. Mo. Pac. R.R. Co., 254 F.3d 825, 829 (9th Cir. 2001) (expert may not rely on "unsupported speculation and subjective beliefs" (citing Daubert, 509 U.S. at 590)). A court thus must closely inspect how the expert arrives at his conclusions and exclude "opinion evidence that is connected to existing data only by the ipse dixit of the expert." Gen. Elec. Co. v. Joiner, 522 U.S. 136, 146 (1997); see also, e.g., Ex. C, Shank v. Whiting-Turner Contracting Co., No. 17-CV-446-JED-FHM, 2018 WL 6681223, at \*2 (N.D. Okla. Dec. 19, 2018) ("analytical gap" in expert's testimony requires its exclusion under Daubert).

The State cannot meet these standards for Duncan's testimony on marketing and causation.

### III. ARGUMENT

# A. <u>Duncan's Testimony About The Supposed Effects Of Pharmaceutical</u> Marketing On Prescribers And Law Enforcement Must Be Excluded

1. Duncan Is Not Qualified To Opine On Pharmaceutical Marketing Or Its Effects

Duncan is a credentialed philosopher with extensive knowledge on addiction—he has no training in marketing and has never taken a class on statistics or probability. Ex. A, Duncan Disc. at 5; Ex. B, Duncan Dep. 44:11-17. He nonetheless seeks to assert broadly that Defendants' marketing "successfully influenced" Oklahoma prescribers and law enforcement officials at the Oklahoma Bureau of Narcotics ("OBN"). Duncan's "knowledge, skill, experience, training[, and] education" do not qualify him to offer that opinion. *See* 12 O.S. § 2702. Indeed, he offers nothing

more than inadmissible lay opinions on marketing that the State attempts to dress up as expert testimony.

Courts across the country regularly hold that an expert must have specialized expertise to opine on the effects of marketing. This is especially so in a heavily regulated and complex environment like the pharmaceutical industry. For example, in *Pfizer Inc. v. Teva Pharmaceuticals USA, Inc.*, 461 F. Supp. 2d 271 (D.N.J. 2006), the court held that a rheumatologist was not qualified to opine on how pharmaceutical marketing affected doctors' choice between different drugs. *Id.* at 276. While the rheumatologist's medical expertise may have allowed him to opine on *general* factors that influence doctors' prescribing decisions, he was not qualified to opine on the *specific* effects of particular marketing efforts because he lacked "specialized expertise regarding sales or market analysis" and "had conducted no scientific studies or surveys concerning purchasing practices of other doctors in his field." *Id.* By contrast, in *Pooshs v. Phillip Morris USA, Inc.*, 287 F.R.D. 543 (N.D. Cal. 2012), the court allowed an epidemiologist who had "published peerreviewed articles on cigarette advertising and marketing" and who based his opinion on "original data" and "published articles" to opine on the effects of cigarette advertising. *Id.* at 552-53.

Like the expert excluded in *Pfizer*, Duncan lacks any "specialized expertise" in "market analysis." *See Pfizer Inc.*, 461 F. Supp. 2d at 276. And, in contrast to the qualified expert in *Pooshs*, Duncan has not published any literature on pharmaceutical marketing. *See Pooshs*, 287 F.R.D. at 552-53. Absent specialized expertise, a purported expert may not give "broad opinions on the prescribing practices" or other effects of marketing. *See Pfizer*, 461 F. Supp. 2d at 276. The Court should thus disqualify Duncan from testifying on this highly specialized topic.

# 2. Duncan Provides No Reliable Basis For His Opinions About Marketing

Duncan's opinion about marketing must also be excluded because it is not "based upon sufficient facts or data" and is not "the product of reliable principles and methods." See 12 O.S. {\$5505477;2}

§ 2702. Having no training or experience in analyzing the effects of marketing, Duncan uses none of the tools a qualified expert would use to analyze the effects of marketing on Oklahoma doctors and law enforcement. He did not conduct any surveys, collect any data, or even interview anyone. In lieu of a reliable data-based analysis, Duncan offers personal anecdotes and unmathematical efforts to transform purported correlation into causation. Duncan's personal anecdotes are not a reliable basis for an expert opinion. And even if they were, Duncan admits that his personal experience relates only to Purdue and that he has no experience with the marketing campaigns of any other remaining Defendant.

#### a. Duncan's Marketing Opinion Lacks Any Reliable Basis in Data

Courts consistently require an expert to provide empirical data and analysis to support his assertions about the effects of pharmaceutical marketing. For instance, in Pfizer, the court held that a purported expert could not offer an opinion about the effects of pharmaceutical marketing on drug prescriptions when that purported expert "had conducted no scientific studies or surveys concerning purchasing practices of other doctors in his field." 461 F. Supp. 2d at 276. Similarly, in Advanced Medical Optics, Inc. v. Alcon Inc., the court rejected a doctor's opinion about the causes of sales of a particular medical device because the doctor based his opinions only on personal observations of his colleagues' preferences and did not perform any survey research to determine if their views were widely shared. Ex. D, No. 03-1095-KAJ, 2005 WL 782809, at \*4 (D. Del. Apr. 7, 2005).

Duncan's opinion—based on no data whatsoever, much less a scientific study or survey does not meet this standard. Duncan has not even spoken to any doctors or law enforcement officers about how marketing affected them. Ex. B, Duncan Dep. 211:10-17; 212:18-24; 293:14-17. In Duncan's words, he has not "talked to a prescriber at all and asked them whether they were influenced by" marketing. Id. 213:12-13. In fact, beyond his own personal experience with Purdue, 5

Duncan is "not aware of any specific prescribers or law enforcement officials at OBN who were convinced or assuaged by any marketing efforts by other defendants." *Id.* 233:12-17. And Duncan admits that, while he was at OBN, he did not look at prescribing data from OSTAR (Oklahoma's former Schedule II drug database) or its successor, the Prescription Monitoring Program ("PMP")—and he certainly made no attempt to use OSTAR or PMP data to analyze the impact of pharmaceutical marketing. Ex. B, Duncan Dep. 297:4-21; *see also id.* 193:5-8 (admitting that OBN did not "draw statistics" about opioid prescribing at treatment centers).

Given his total lack of data, Duncan's purported method for drawing a relationship between opioid marketing and its effects is unscientific and unreliable. Duncan commits the classic fallacy of confusing correlation with causation—he manufactures a conclusion about the effects of marketing from a mere coincidence in time between a marketing message and a change in behavior. *See id.* 294:16-18 (Duncan's "method" for establishing the effects of pharmaceutical marketing is to observe the "proximity of them actually making that behavioral change and when they found this message, when they were told this new information").

But even if he had data that would allow him to establish "proximity" between a marketing message and behavioral change, that *correlation* is not a reliable method for establishing that the marketing message *caused* the behavioral change. Even a well-supported, mathematically calculated correlation is not causation, and that is a central flaw in Duncan's so-called method. *See Norris v. Baxter Healthcare Corp.*, 397 F.3d 878, 885 (10th Cir. 2005) (rejecting expert opinion that breast implants cause disease because opinion was based "solely on differential diagnosis and case studies"); *cf. In re Neurontin Mktg. & Sales Practices Litig.*, 712 F.3d 21, 42 (1st Cir. 2013) (accepting a linear regression model as a method for establishing the effects of pharmaceutical

marketing). Duncan admits as much, testifying that his "method" cannot produce "determinatively causal" results. Ex. B, Duncan Dep. 294:23-295:4.

b. Duncan's Personal Experiences With Marketing Are Insufficient Basis For His Opinion And Involve Only Purdue

Duncan's personal experiences with Purdue's pharmaceutical marketing cannot save his marketing opinion. First, an individual's personal experience is an insufficient basis for offering a broad opinion on the effects of marketing on large groups of people. Second, even if personal experience were sufficient, Duncan's personal experience with opioid-related marketing is limited to Purdue's marketing. He offers no reasonable method for extrapolating from his experience with Purdue to opine on other Defendants.

In an attempt to support his opinion that pharmaceutical marketing changed prescriber and law enforcement behavior, Duncan testified that he witnessed Purdue marketing to doctors and that he has a personal recollection that OBN deferred to allegedly Purdue-influenced medical professionals on appropriate opioid prescribing. Ex. B., Duncan Dep. 154:1-12, 155:3-24, 166:6-169:3. But courts hold that one person's "personal experience" with pharmaceutical marketing is an insufficient basis for him to opine generally on others' broader experiences with that marketing. See, e.g., Pfizer, 461 F. Supp. 2d at 277-78 ("The fact that [a doctor] received frequent visits from Pfizer representatives, and that several of his patients requested Celebrex prescriptions does not alone support a conclusion that Celebrex's prescriptions were heavily influenced by advertising and promotion." (emphasis in original)); Ex. E, In re Trasylol Prod. Liab. Litig., No. 08-MD-01928, 2010 WL 4052141, at \*7 (S.D. Fla. May 12, 2010) (excluding testimony on pharmaceutical marketing where the testimony was based only on the expert's personal experience of the marketing). Duncan's personal observations of Purdue's marketing are insufficient to give him insight into how doctors and personnel at OBN in general reacted to that marketing.

Moreover, Duncan's personal experiences have nothing to do with Janssen or Teva. Courts routinely hold that a purported expert must have knowledge about a particular company or product to offer an admissible opinion on that company or product. *See, e.g., JFJ Toys, Inc. v. Sears Holdings Corp.*, 237 F. Supp. 3d 311, 323 (D. Md. 2017) (rejecting marketing opinion of purported expert with years of experience in toy sales because the expert lacked experience with the "particular" toy at issue); *R.F.M.A.S., Inc. v. So*, 748 F. Supp. 2d 244, 268 (S.D.N.Y. 2010) (rejecting jewelry industry CFO's opinion on why a retailer reduced its prices because he had no experience with that particular retailer).

Duncan's personal experience involves only Purdue. Ex. B., Duncan Dep. 172:1-174:18, 216:24-218:24 ("In my personal experience that, you know, the things that I was involved in, all I remember is the presence of Purdue Pharma people."). Duncan does not remember interacting with sales representatives from any Defendant other than Purdue. *Id.* 301:2-25. Duncan is not aware of any prescribers who were influenced by any Defendants other than Purdue. *Id.* 212:18-214:25. Duncan admits that he does not know of any doctors who were influenced in any way by Teva or Janssen. *Id.* 219:1-7, 292:1-10. Duncan is not even familiar with Janssen's opioid products, repeatedly referring to Nucynta as "lucynta." *Id.* 285:23, 286:4. And Duncan admits that he is not aware of any Defendants other than Purdue influencing OBN decision-making on opioids. *Id.* 234:9-235:5 ("[Defendants other than Purdue] did not influence -- directly influence OBN policy. No, sir.").

Duncan offers no reasonable method for extrapolating from his experience with Purdue to other Defendants. Duncan's only basis for comparing other Defendants to Purdue is that the State's counsel showed him "similar types of documentation" from other Defendants, leading to a vague "belief" that other Defendants and Purdue did "something similar." *Id.* 212:9-15. But the State

showed Duncan only 11 "similar types" of documents, each handpicked by the State. Ex. F, April 15, 2019 Letter. Duncan did not look at any of these documents until the day before his deposition, Ex. B, Duncan Dep. 274:13-15, and, during his deposition, Duncan could not recall key details, like whether certain Defendants were even represented in the documents, *e.g.*, *id.* 209:4-210:23 (responding to a question about whether he had seen Actavis documents: "Let me look at the list, and I can tell you from the list. I can't remember them off the top of my head. I'm an old man."). Duncan has done no analysis of any of the purported "similarities" between Purdue's marketing and other Defendants' marketing. When Duncan admits that "the value of that observation" regarding "similar things" occurring with other pharmaceutical companies "has [yet] to be determined," *id.* 216:14-23, he is correct.

# B. Duncan's Opinion On The Causes Of The Opioid Epidemic Is Inadmissible

# 1. Duncan Is Not An Expert In Causation

Duncan also purports to offer an opinion on the "cause ... of the opioid crisis in Oklahoma." Ex. A, Duncan Disc. at 1. But Duncan is even less qualified to opine on the cause of a complex epidemiological phenomenon than he is on pharmaceutical marketing's effects on law enforcement and prescribers. Courts consistently exclude causation opinions offered by purported experts who lack medical or epidemiological expertise. See, e.g., Haynes ex rel. Haynes v. Nat'l R.R. Passenger Corp., 319 F. App'x 541, 542 (9th Cir. 2009) (expert not qualified to opine that train travel causes deep-vein thrombosis given lack of expertise in "medicine, public health, epidemiology, DVT, or train travel"); cf. Wagoner v. Exxon Mobil Corp., 813 F. Supp. 2d 771, 800 (E.D. La. 2011) (allowing a physician with a "substantial interest in epidemiology" to offer a general causation opinion). There is no reason for this Court to apply a different standard.

Duncan lacks any relevant qualifications. He has no training in epidemiology and has never taken a class on statistics or probability. Ex. A, Duncan Disc. at 5; Ex. B, Duncan Dep. 44:11-17. Duncan's training on analyzing cause and effect apparently consists of reading the works of a Scottish philosopher who died in 1776:

Q. (By Mr. Bartle) [D]uring the course of your education, Doctor, did you take any classes on cause and effect?

A. I read David Hume. ... I'm familiar with the philosophy of cause and effect.

Ex. B, Duncan Dep. 43:12-23. Eighteenth-century philosophy is interesting, but it in no way qualifies an expert witness to opine on epidemiological causation in 21st-century Oklahoma.

2. Duncan Provides No Reliable Basis For His Opinion About The Cause Of The Opioid Epidemic

Duncan also lacks any reliable basis or method for offering an opinion on the causes of the opioid epidemic. As the Oklahoma Supreme Court has emphasized, an "expert's opinion on causation must be more than *ipse dixit.*" *Christian*, 2003 OK 10, ¶¶36-39, 65 P.3d at 607. Rather, the testimony must be "based upon a reliable method for determining causation," and his "conclusion" must be "analytically appropriate to that method." *Id.* For example, courts accept the use of a linear regression model to establish causation. *See, e.g., In re Neurontin*, 712 F.3d at 42 ("[R]egression analysis is a well-recognized and scientifically valid approach to understanding statistical data, and courts have long permitted parties to use statistical data to establish causal relationships.")

But, here, Duncan offers no reliable method. Without data or evidence, Duncan asserts that there was an "overlap" and a "sequential relationship" between the marketing he observed and Oklahoma's opioid epidemic. Ex. B, Duncan Dep. 186:17-187:2. Duncan "can't remember dates" for this supposed sequential relationship and admits he uses the term "opioid crisis" colloquially and is "not using it as an epidemiologist or someone that has an epidemiological study to back up

that word." *Id.* 187:3-8, 19-24. And even if Duncan did use data, his observation of a "sequential" relationship would be insufficient to reliably establish causation. Again, *correlation* is insufficient, without more, to establish a *causal* relationship between marketing and prescribing. *Norris*, 397 F.3d at 885.

# IV. <u>CONCLUSION</u>

For all these reasons, the Court should grant Defendants' Motion to Exclude and issue an order barring the State from introducing Duncan's testimony about both (1) the purported effects of Defendants' opioid marketing on opioid prescribing in Oklahoma and Oklahoma law enforcement efforts and (2) any purported causes of the opioid epidemic in Oklahoma.

# Dr. Duncan is expected to testify about the following subject matters:

- The cause and early development of the opioid crisis in Oklahoma.
- The influence of Defendants' deceptive marketing campaign on Oklahoma State law enforcement efforts at the Oklahoma Bureau of Narcotics and Dangerous Drugs ("OBN").

Prior to 1996, there was no opioid crisis in the State of Oklahoma. However, in the years

# Dr. Duncan is expected to testify about the following facts, and/or opinions:

that followed, the opioid addiction epidemic began to rear its head in Oklahoma. At all relevant times, OBN was vigilant in its efforts to curb drug diversion and abuse. Before the opioid crisis fully gripped the State of Oklahoma, OBN watchfully tracked the prescribing of Schedule II narcotics. Due to limited resources, OBN focused on the problems at hand within the budget it had. Over time, more resources would be dedicated to the growing opioid problem, which replaced previous drug diversion and trafficking problems in the State.

In the late 1990s and early 2000s, Defendants successfully influenced the understanding of prescribers and State law enforcement officials at OBN about safety of time-released opioids used to treat chronic pain by claiming they were significantly less addictive. Such efforts crafted change in the perspectives of both prescribers and regulators and, in fact, increased the overall availability opioids for both medicinal and non-medicinal use, which allowed the opioid crisis to grow silently. In particular, though prescribers and law enforcement had for decades viewed opioids as highly addictive and dangerous substances subject to diversion and trafficking,

Defendants used medical education events, key opinion leaders, dinner events and other tactics

to convince both prescribers and law enforcement that long-acting opioids were not addictive because the long-acting formulation prevented the occurrence of a "high" and any perceivable pleasure from the drug would be absorbed by the patient's pain due the steady, long-acting release mechanism.

Defendants' deceptive message convinced and assuaged both prescribers and law enforcement at OBN that long-acting opioids were generally safe and non-addictive. As such, Defendants successfully influenced policy and decision making at OBN in a negative manner. In short, Defendants infiltrated the OBN policy and decision-making process, using State law enforcement a pawn in Defendants' massive chess game aimed at increasing opioid prescribing in the State.

# C. The summary of the grounds for each opinion is as follows:

Dr. Duncan worked at OBN for 22 years, where, as Chief Agent, he oversaw projects related to the diversion and trafficking of controlled pharmaceutical drugs, such as narcotic analgesics. Dr. Duncan was intimately involved in the policy and decision-making at OBN related to deterring abuse, diversion, and trafficking of controlled pharmaceuticals, including opioids. In his official capacity at OBN, Dr. Duncan was invited to numerous speaking events and dinners hosted by and paid for by the Defendants and at which Defendants promoted their opioid drugs as non-addictive. Through this experience, Dr. Duncan came to know many of the speakers employed or paid by the Defendants to disseminate this message on their behalf.

Prior to his career at OBN, Dr. Duncan was a police officer for the Norman Police Department, where he also became a member of the SWAT team.

In 1998 Dr. Duncan received a Ph.D. from The University of Oklahoma ("OU") and now teaches at OU and OU Health and Sciences Center (better known as OU Med School). Among

other things, Dr. Duncan teaches first year medical students about the dangers of prescribing certain abusable pharmaceuticals and the effects of such pharmaceuticals on the human brain.
