
**THE STATE OF OKLAHOMA’S RESPONSE TO DEFENDANTS’ RENEWED
MOTION FOR JUDGMENT**

Following the close of the State’s case-in-chief, and in response to Defendants’ first Motion for Judgment, this Court correctly found that “there is sufficient evidence of the State’s nuisance claim against the Janssen defendants to deny the defendants’ motion for judgment.” Trial Tr. (7/08/18, hearing) at 89:4-11. Nothing changed following

Defendants' case-in-chief. In fact, nearly every witness Defendants called provided further evidentiary support for a finding in the *State's* favor, and not in favor of Defendants. The evidence and legal authority demonstrating this are set forth in detail in the State's proposed Findings of Fact and Conclusions of Law in Support of the Court's Final Judgment ("FOF/COL"), which the State has filed contemporaneously herewith and incorporates as if fully set forth herein.

Based on the evidence presented at trial and the applicable law, and as demonstrated in the FOF/COL, the State respectfully requests that the Court deny Defendants' Renewed Motion for Judgment.
