ORDER

The defendants Teva Pharmaceuticals USA, Inc. and Cephalon Inc. and related companies (collectively “the Teva defendants”) and intervenor CBS News, a division of CBS Broadcasting Inc (“CBS News”), are before the Court on September 5, 2019, for a hearing to clarify an issue regarding documents requested by CBS News that remain sealed. The Teva defendants appeared in person through their counsel, Nicholas V. Merkley; CBS News appeared telephonically through its counsel, Robert D. Nelon.

At issue is a portion of the State of Oklahoma’s response, filed on April 2, 2019, to the Teva defendants’ Motion for Partial Summary Judgment, filed March 15, 2019, which remains under seal. The objection of the Teva defendants to unsealing that remaining sealed portion of the State’s response is that the 2005 “Supply & Distribution Agreement” between Purdue Pharma, LP and Watson Pharma Inc. is an exhibit. The Court, after a previous closed hearing, directed the Teva defendants to file a redacted version of that agreement, which the Teva defendants did on August 22, 2019. After discussion between counsel and the Court, the Teva defendants agreed to provide CBS News on or before September 10, 2019, with a hard copy of the State’s Response in Opposition to Defendants Watson Laboratories, Inc., Actavis LLC, Actavis Pharma, Inc. and Teva Pharmaceuticals USA, Inc.’s Motion for Partial Summary Judgment and Brief in Support, filed on


April 2, 2019. The Teva defendants may omit from the hard-copy production Exhibit 70, the 2005 Supply & Distribution Agreement, which the Teva defendants previously filed in redacted form.
