
DEFENDANTS JOHNSON & JOHNSON AND JANSSEN PHARMACEUTICALS, INC.'S ADOPTION OF PURDUE'S RESPONSE TO DR. REGAN NICHOLS' MOTION FOR THIRD-PARTY EXCEPTION TO PROTECTIVE ORDER

Pursuant to Oklahoma Stat. tit. 12 Section 2010(C), Defendants Johnson & Johnson and Janssen Pharmaceuticals, Inc. respectfully adopt as their own the October 7, 2019, Response to Dr. Regan Nichols' Motion for Third-Party Exception to Protective Order filed by Purdue.

WHEREFORE, Defendants Johnson & Johnson and Janssen Pharmaceuticals, Inc. respectfully request this Court enter an order consistent with that of Judge Mai in the criminal trial court, allowing Nichols access to the documents at issue, but DENYING her request that her access


