PO Schoulcraft's father called "City Hall," and
spoke to the Dep Mayor Sleyler's assistant. The
father said that his son was never told why he is
on R/D. Sgt Bonvillia reached out to PO
Schoulcraft who said he was never told why he
is on R/D.

I told Sgt Bonvillia that Dr. Lanstein was
away, so could not report in an exact conversation, but I
read some notes which confirm she "gave feedback," and more.
I told that our policy is to make sure Mos know why
~~the~~ they are being placed in R/D (even if they may
disagree). We also try to direct Mos to places they
can get help, as Dr. Lanstein clearly did.

I told Sgt that Dr. Lanstein would call in
PO Schoulcraft as soon as she returned, ^{and} answer any
questions he may have. Sgt Bonvillia said that was
fine - it ~~was~~ could wait for Dr. Lanstein's return.

Ad explained to Mos that ad called him in immediately upon my return from a 2 wk vacation b/c ad received msg that his father made a explicit statement that ad never told Mos the reason why he is on R/P. Since we had discussed that in detail at his initial & subsequent visits, ad emphatically stressed an uncertainty of how he may not have wanted to tell his father the reason why he was on R/P. In note says that he has a clear understanding of why he is on R/P, ad again explained in detail that he is on R/P b/c he had significant physical manifestations of stress that were causing med disrupt & would benefit from treatment & further monitoring.

Mos sd he no longer has those physical symptoms even though he is still feeling the same stress as before while on R/P, he is still doing PCT daily with complete all day long - not attempt to him, but not any less attempt (in his opinion) as regular F/P visits.

Ad again re-emphasized stress mgmt & relaxation training so the next time he is faced with new increased stress, he won't have a recurrence of the chest pain, headache, morning upset stomach, etc. that he had in several months when he 1st came to PES. He said he bought both books ad recommended & started reading them, but not that helped since not read he didn't know before. He thought the Buros book was kind of corny & preferred the Ellis book. He ~~is~~ bought both books to today's apt & had Bookman in there, ~~but~~ not very far into them (so hasn't read much of them). He said he called a few people of recently but none to a extent & one wanted \$400/hour & told him ad could help him find an Action Hospital & to be sure they must cover 67% of physical & of AHC. He said he would call later to his provider to make sure the provider are in-network, Mos expressed an appreciation of the assistance,
